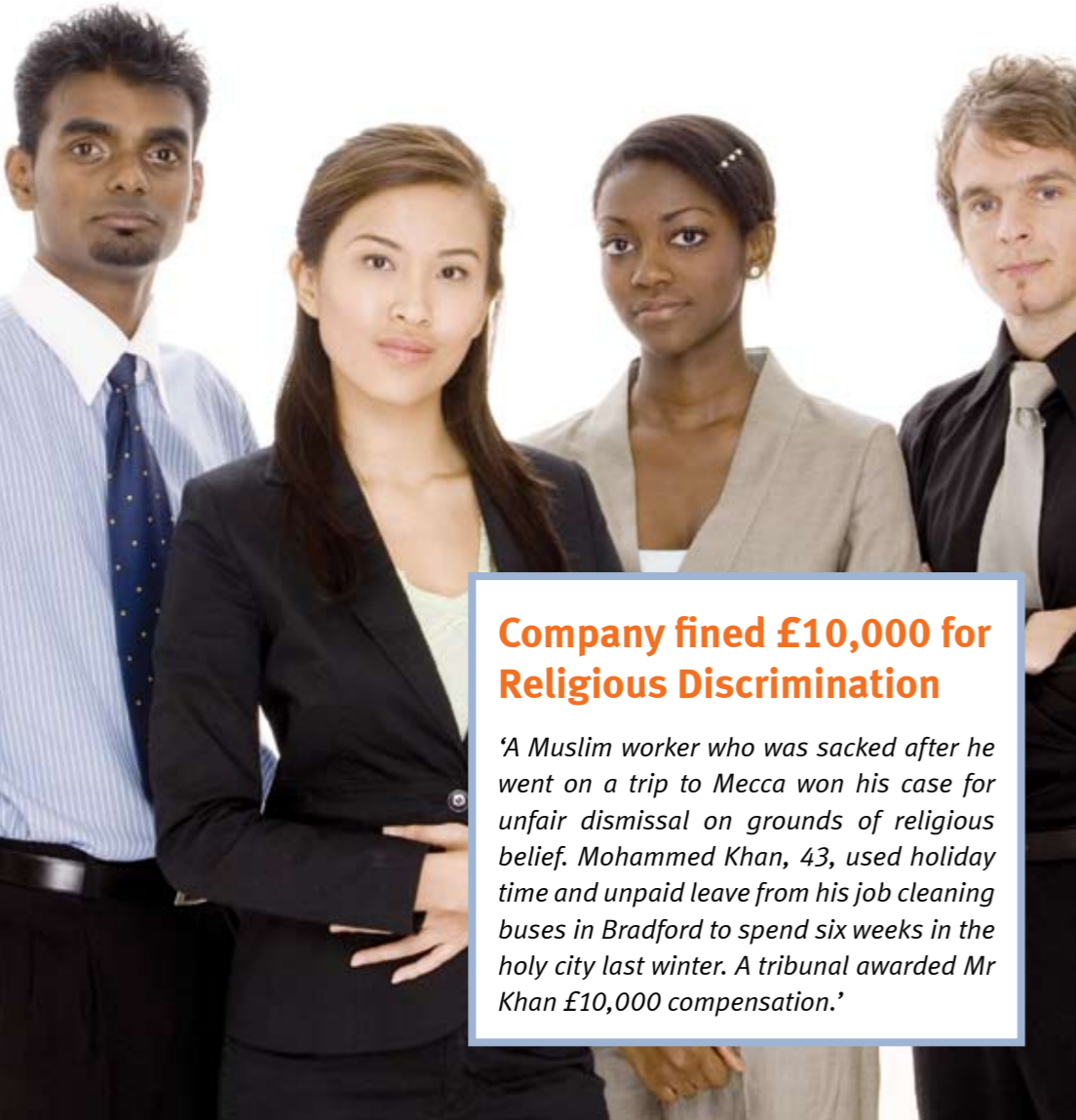

Company fined £10,000 for Religious Discrimination

'A Muslim worker who was sacked after he went on a trip to Mecca won his case for unfair dismissal on grounds of religious belief. Mohammed Khan, 43, used holiday time and unpaid leave from his job cleaning buses in Bradford to spend six weeks in the holy city last winter. A tribunal awarded Mr Khan £10,000 compensation.'

In-House Course

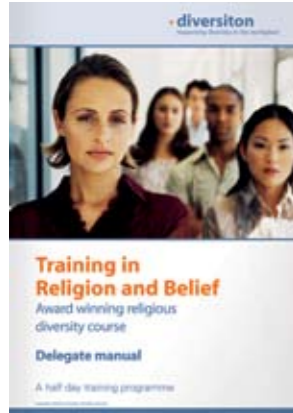
'Religion and Belief in the Workplace' is the UK's leading diversity training programme.

Who is the training for?

This is an important course for all staff. Most organisations:

- Start with a particular department / location, or
- Choose a selection of staff e.g., managers, supervisors or human resource personnel, or
- Begin with the senior team and then work down through the organisation

Numbers & Cost

The programme runs best with 10 or more delegates. Each delegate receives a 60 page training manual. The cost is £79 per person (with a minimum of 10 delegates).

This programme is also run as an open workshop.

By 2011, 35% of the population will be over 55 and all of the indicators are that more people will need to continue working in life.
